Subject: Invitation to take part as an Author on the Conference 'Palić 2010'

It is with great pleasure on behalf of the Association for Insurance Law of Serbia (AIDA Serbia) to invite you to contribute with your work (report, statement, commentary etc.) to scientific and expert success of the annual seminar of lawyers and other experts from insurance that shall traditionally be held in organisation of our Association on Palić (lake near Hungarian border, 180 km from Belgrade) on 23 and 24 April 2010.

General theme of this 11th annual Conference is 'European reforms in Serbian insurance Law – Palić 2010'. Conference shall be organised into four parts: General Issues of Insurance Law and Economy, Non-Life Insurance, Insurance of Persons and Insurance Contract. Conference will have an international flavor because among authors from Serbia, there will be authors from the EU Member-States.

Highly appreciating your expertise and scientific competence for insurance law, other adequate area of insurance or with insurance law connected professional or scientific fields I strongly believe that your work shall meet the following expectations of the organiser:

1) work addresses issue(s) from the contemporary point of view and level in a subject insurance field or with insurance connected fields in the EU and/or EU member countries (work may address issues provided for by the EU legislation, their application, insurance practice in a certain field, i.e. in certain classes of insurance, insurance conditions, court authorities etc.)

2) Work contains adequate solutions for the field being reviewed in your country and proposals that may serve to insurance in Serbia, i.e. to a relevant field connected with insurance,

3) work has not been published entirely or in prevailing part with the same content and has not been written for handing over for publishing in entirety or prevailing part with the same content to some other publisher until the end of the Conference,

4) Work has approximately one author's sheet (30,000 characters) and summary in addition of up to one page (up to 28 rows) and

5) Work is submitted to our Association until 25 January 2010 to the addresses designated in this letter of invitation.

As usual, works shall be published in the Memoir aimed at the seminar participants and sponsors. Each work should be written in English language, which shall then be translated into Serbian. Number of works on the seminar and in the Memoir is limited by the time planned for debate, i.e. by the time planned for the Conference (maximum between twenty and twenty-five
